Discussion of Resolution 2017-11 to Agree to be Responsible for the Maintenance and Operation of the Pleasant Valley Trail for its Intended use and to Justify the Project in Public use for a Minimum of Twenty (20) Years Following Project Completion per the Iowa State Recreational Trails Program Funding. Council Member Clough discussing the amount of funds that are available from the State of Iowa in regards to the trails grant. He will send in an application for the grant. The grant requires the city take care of the trail for 20 years after completion.

Resolution Number 2017-11 AUTHORIZING AN AGREEMENT TO BE RESPONSIBLE FOR THE MAINTENANCE AND OPERATION OF THE PLEASANT VALLEY TRAIL

WHEREAS, the City of Ida Grove, Iowa (the "City"), has established the Pleasant Valley Trail system and has maintained the trail since inception; and

WHEREAS, the City has undertaken a grant application from the lowa Department of Transportation called the lowa State Recreational Trails Program (the "Project"); and

WHEREAS, in order to cover 60% of the costs of the Project and to make such costs eligible to be reimbursed from the lowa Department of Transportation the City is supporting the Project;

NOW, THEREFORE, IT IS RESOLVED by the City Council of the City of Ida Grove, Iowa, as follows:

It is hereby directed the City will agree to be responsible for the maintenance and operation of the Pleasant Valley Trail for its intended use and to justify the project in public use for a minimum of twenty (20) years following project completion per the lowa State Recreational Trails Program Funding grant.

Said resolution is passed by city council by a vote of 4 in favor and 0 opposed.
