Mayor Whiteing called the meeting to order at 5:02 pm with the following council members present: Paul Cates, Ryan Goodman, Gregor Ernst, Doug Clough and Scott Tomlinson. Water department supervisor, Lon Schluter, was also in attendance.

Motion by Ernst to approve the agenda, second by Tomlinson. On a unanimous vote, motion carried.

Council directed Sweeden to re-allocate the percentage of wages based on justifiable work done in the water department for Parks Superintendent Bob Lorenzen. Sweeden will then recalculate FICA, IPERS, Medicare, health insurance and workers comp insurance based on the new wage estimates to be funded by the water department. Council discussed the need for water tower painting in the next few years. Sweeden was directed to make the adjustments talked about and put any remaining budget surplus for FY20 into the capital improvements line item to create a balanced budget.

Motion by Goodman to approve Resolution 2019-3 resolution amending the code of ordinances for the City of Ida Grove, IA by enacting an ordinance governing accessory buildings within the City of Ida Grove, IA, second by Ernst. On a unanimous vote, motion carried.
