## **ORDINANCE NUMBER 576**

## AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF IDA GROVE, IOWA BY AMENDING PROVISIONS TO THE MUNICIPAL WATER AN D SEWER UTILITIES

BE IT ENACTED by the City Council of the City of Ida Grove, Iowa, that:

**SECTION 1.** MODIFICATION OF CODE. Chapter 13.05.250, "Rates and Service"

1. Rates for metered water service shall be:

Gallons per month	Rate
First 2,000 gallons	<del>\$21.42</del>
2,001 – 9,999 gallons	\$3.79 per 1,000 gallons
10,000 – 99,999 gallons	\$3.44 per 1,000 gallons
100,000+ gallons	\$2.71 per 1,000 gallons

SECTION 2. MODIFICATION OF CODE. Chapter 13.20.100 "Sewer Rates"

2. Rates for sewer service shall be:

Gallons per month	<u>Rate</u>
First 2,000 gallons	\$19.31
2,001+ gallons	\$6.71 per 1,000 gallons

**SECTION 3.** DELETION OF CODE SECTION. Chapter 13.20.110 "Deposit and allocation of funds" is hereby removed from the Ida Grove City Code as it is no longer valid or in effect.

- (1) Sewer charges collected from customers within the city shall be deposited in special accounts in accordance with the following schedule:
  - a. One dollar and eighty cents per 1,000 gallons operation account/maintenance account.
  - b. Sixteen cents per 1,000 gallons replacement account.
- (2) Sewer charges collected from customers outside the city shall be deposited in special accounts in accordance with the following schedule:
  - a. Two dollars and seventy cents per 1,000 gallons operation account/maintenance account.
  - b. Twenty-four cents per 1,000 gallons replacement account.

**SECTION 4.** ADDITION TO CODE. Chapter 13.20.110 "Rates outside the City" is hereby added as a new section to the Ida Grove City Code to read as follows:

## Section 13.20.110 – Rates outside the City

Sewer service shall be provided to any consumer located outside the corporate limits of the city whom the city has agreed to serve at 150 percent times the rates provided in IGCC 13.20.100. No such consumer, however, will be served unless the customer shall have signed a service contract agreeing to be bound by the ordinances, rules and regulations applying to sewer service established by the council.

**SECTION 5.** REPEALER. All ordinances or parts of ordinances except for the 150% surcharge for services outside of the city limits and sewer averaging that are in conflict with this ordinance are repealed to the minimum extent necessary to comply with this ordinance. If any portion of this Ordinance is determined to be invalid, such determination shall not affect the remainder of the Ordinance.

**SECTION 6.** SEVERABILITY CLAUSE. If any section, provision or part of this ordinance is adjudicated to be invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 7**. EFFECTIVE DATE. This Ordinance shall be in effect for bills dated on and after January 1, 2020 and after its final passage, approval and publication as provided by law.
