

**RESOLUTION NO. 2022-11**

**RESOLUTION APPROVING THE ANNUAL BUDGET FOR FISCAL YEAR  
2022-2023 FOR THE CITY OF IDA GROVE, IOWA**

**WHEREAS**, the Code of Iowa, Chapter 384, Section 16, requires that all cities prepare and adopt an annual budget of expenditures and receipts for at least the next fiscal year; and,

**WHEREAS**, the City Council has held budget workshops and given direction for budget decisions; and,

**WHEREAS**, the City Clerk has prepared the FY2022-2023 budget according to City Council direction as required by the State of Iowa; and,

**WHEREAS**, the City Clerk shall certify the necessary tax levy for the next fiscal year to the County Auditor by March 31, 2022; and,

**WHEREAS**, the Notice of Public Hearing Budget Estimate was published on March 9, 2022 and the Ida Grove City Council did hold a public hearing concerning the budget for the FY 2022-2023 on March 21, 2022; and,


**WHEREAS**, the City Clerk is hereby authorized to transfer the following funds as provided for in the certified budget:
