Bark, Tree limbs and branches not exceeding six inches in diameter and eight feet in length.

Illegal Dumping:

NO dumping of plastic bags or other containers, compost, garbage and building materials.

NO removing of tree limbs without authorization of the City.

NO dumping of tree limbs other than hours of operation.
